Welcome to Excellence in Brief



ACELG's 2012 program is now well under way. Both the Board and the Research Advisory Committee met in March. The Committee met in Melbourne and adopted a research strategy for 2012 that includes several major new projects, notably in the area of local government finance, as well as another round of funding under ACELG's research partnerships scheme. We look forward to collaborating with a range of local government partners to expand the research agenda and support evidence-based policy and debate.

As reported below the Board met in Hobart and approved the overall 2012 work program. Details are now available on the ACELG website under each program area. Our meeting in Hobart, together with a roundtable discussion with representatives of Tasmanian local government, was generously hosted at Parliament House by the Deputy Premier and Minister for Local Government, Hon Bryan Green. The roundtable was also attended by Mayor Barry Easter, President of the Local Government Association of Tasmania.

A similar roundtable was held in Melbourne, supported by the Municipal Association of Victoria, which also hosted the Research Advisory Committee. We greatly value our positive working relationships with local government associations and departments in all states and the Northern Territory. An important decision at the Board meeting was to establish a partnership with ALGA to jointly fund an annual report on the state of local government road assets over the next 3 years.

ACELG will be spending some \$3.25m in 2012 on a wide range of activities aimed at advancing the interests and performance of Australian local government. The five consortium partners will contribute \$460,000 of that amount from their own resources. This represents a very considerable ongoing commitment, and we are confident the positive results of our efforts will be seen by councils and communities throughout Australia.

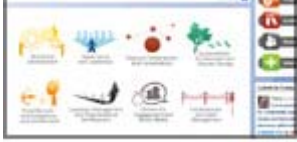

Collaborative metropolitan governance

Collaborative Governance and Metropolitan Planning in South East Queensland - 1990 to 2010: From a Voluntary to a Statutory Model.

This report was prepared as part of the 2011 Research Partnership Scheme. It provides a brief history of metropolitan planning in SEQ from 1996 to 2010, focusing on the factors behind the move from a voluntary to a statutory planning model and drawing out the lessons for other states and multi-level planning regions.

It was prepared by Dr John Abbott for ACELG in collaboration with the Council of Mayors SEQ and the Queensland Department of Local Government and Planning (Growth Management Queensland).

Rural-remote and Indigenous local government



New research: Role and expectations

ACELG has released a new research report prepared by Alan Morton entitled *Role and expectations of rural-remote and Indigenous Local Government*. The report examines what is needed to achieve a sustainable model of rural-remote and Indigenous local government. It includes a profile of rural-remote councils; documents federal, state and local government expectations; and identifies further actions and research. The findings and recommendations have been incorporated in the program of activities under ACELG's rural-remote and Indigenous local government program for 2012. Download the paper [here](#).

CEOs survey

ACELG has completed a survey of CEOs in rural-remote and Indigenous local government to explore the issues surrounding capacity building in these councils. The survey findings will be discussed at a search conference of CEOs from rural-remote and Indigenous councils in July, and will be used to inform the ACELG strategy aimed at addressing the capacity needs of small rural-remote and indigenous local governments. The survey report will be released in the coming weeks, and will be available to download from the ACELG website.
